The blank nomination form can be had from the said Returning Officer or from the undersigned or from the branch premises effective from **18**<sup>th</sup> **February, 2019 till 5.00 PM of 20**<sup>th</sup> **February, 2019**, i.e. the last date of receipt of nominations.
