

1.	Last Date of receipt of nominations (atleast 10 days before the date of polling)	14/02/2022
2.	Date of scrutiny of nominations (within two days from last date of nominations)	16/02/2022
3.	Display of list of valid nominations on the Notice Board of the Branch (Date of scrutiny, i.e., date applicable for S.No. 2)	16/02/2022
4.	Last date for withdrawal of nominations (Two days from the date of display of valid list of nominations.)	18/02/2022 up to 04.00PM
5.	Display of final list of nominations (after withdrawals, if any) (within one day of last date of withdrawal)	19/02/2022
6.	Date of Election (if the nominations exceed more than the number of vacancies) (As per Schedule)	24/02/2022
7.	Declaration of Result (As per Schedule)	As per Head Office
